3. We understand that a **15%** (General auctions) **or 18%** (Premier auctions) **buyer's premium** will be added to the final hammer price ("sold" price) of each lot.
4. We understand that items paid for by **cash or check and removed** no later than **5 PM the day after the auction** (Tuesday) will receive a **3% discount** on the buyer's premium.
5. We understand that each time we request a new bidder number for future auction sessions **this agreement shall be in effect.**

### CREDIT CARD REGISTRATION, PRIVACY AND USE; ITEM REMOVAL DEADLINES; UNPAID ITEMS

Pacific Galleries, LLC requires that each bidder submit a credit card number as a guarantee of payment. The card will NOT be charged until seven (7) days following the sale, and then only for unpaid items won at the prior week's auction. All credit card information is held securely and will not be used for any purpose other than collecting payment after the grace period. In the event a credit card is not available a \$200 cash deposit will be accepted.

1. All purchases must be paid for and removed by seven (7) days after the sale. We understand that we will be assessed an additional **five percent (5%)** of the purchase price starting the second Tuesday after the auction; items that have been paid for but not removed also qualify for the fee (arrangement for storage may be negotiated).
2. If items are **paid for, but are not removed within two weeks** (14 days) of the sale, we understand that Pacific Galleries reserves the right to re-sell items for us under the terms of the auction *Consignment Agreement*.
3. **If items are not paid for and removed after two weeks** (14 days) from the date of the sale, Pacific Galleries reserves the right to rescind the sale of unpaid items and to re-offer those items in future auctions.
